The signatory to this contract acknowledges and understands that:

- 1.1. In the case where instalment payments are applicable, the "AGREED PAYMENT PLAN" section must be filled with respect to the remaining amount, the student and the person responsible for making payments must submit Copy of IDs and if a company is responsible for the payments they must provide an undertaking in writing on company letterhead.
- 2. Failure by student to attend any classes will not reduce his/her liability with respect to the contract.
- 3. Should the student miss any classes it is his/her obligation to arrange and bear the cost of catch-up classes with the lecturer that will be assigned to do so by the management. This arrangement must be done on time to avoid further overlapping of more classes.
- 4. CATCH-UP classes are not compulsory and not part of our obligations with respect to the contract but will be provided as a token of our goodwill & commitment towards student's exam success.
- 5. A minimum of three registered students are required to start running a module for group classes.
- 6. The learner undertakes to settle his/her account in time and acknowledges that access to classes may be denied as a result of none or late payment.
